ORDINANCE NO. SP- 2254, S-2013.

AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NUMBER 2 GENERAL FUND BUDGET FOR FISCAL YEAR 2013 IN THE SUM OF THIRTY SEVEN MILLION THREE HUNDRED TWENTY FOUR THOUSAND NINE HUNDRED NINETY FIVE PESOS (PHP37,324,995.00) TO DEFRAY THE COST OF ELECTRICITY AND POWER CHARGES WITH THE MANILA ELECTRIC COMPANY (MERALCO).

WHEREAS, since Fiscal Year 2009, the city government has been in negotiations with the Manila Electric Company to reconcile its records, billings and payments representing electricity and power consumption of the city;

WHEREAS, on 07 February 2013, Mayor Herbert M Bautista entered into an Agreement with the Manila Electric Company settling power and electricity consumption arrearages;

WHEREAS, it appears that the city government has "receivables" in the amount of Thirty Seven Million Three Hundred Twenty Four Thousand Nine Hundred and Ninety Five Pesos (PHP37,324,995.00) recorded in the books of the Accounting Department under Journal Entry Voucher 2013-04-003616;

WHEREAS, under the agreement, the amount representing the overpayment shall be applied in favor of prior years power and electricity consumption charges of the city.


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN A SPECIAL SESSION ASSEMBLED:

SECTION 1. APPROPRIATION. There is hereby appropriated the amount of Thirty Seven Million Three Hundred Twenty Four Thousand Nine Hundred and Ninety Five Pesos (Php37,324,995.00), by way of this Supplemental Budget Number 2 to the 2013 General Fund Budget, to defray the cost of electricity and power charges of the city government.

SECTION 2. EXPENDITURE. - Expenditure of the amount of Thirty Seven Million Three Hundred Twenty Four Thousand Nine Hundred and Ninety Five Pesos (Php37,324,995.00), in accordance with specific items of expenditures is hereby broken down as follows:

SECTION 4. EFFECTIVITY. - This Ordinance shall take effect immediately upon its approval.


