ORDINANCE NO. SP. 2317 , S-2014

AN ORDINANCE AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ACQUIRE THROUGH NEGOTIATED SALE OR EXPROPRIATION A PARCEL OF LAND IDENTIFIED AS LOT 113-B-2, PSD-10809 COVERED BY TRANSFER CERTIFICATE OF TITLE (ICT) NO. RT-97874 (57558), CONTAINING A GROSS AREA OF THIRTY FOUR THOUSAND TWO HUIDDRED TWENTY FIVE (34,225) SQUARE METERS, MORE OR LESS, REGISTERED UNDER THE NAME OF M.S. FLORENDO AND SONS, INC., LOCATED ALONG PAYATAS ROAD, BARANGAY PAYATAS, QUEZON CITY, PURPOSELY TO BE UTILIZED AND DEVELOPED AS THE SITE OF THE NEW QUEZON CITY JAIL.

WHEREAS, the existing Queezon City Jail located in Barangay Kamuning is already too congested and could no longer accommodate additional correctional facilities or buildings for expansion:

WHEREAS, the location of the existing City Jail has been surpassed and overwhelmed by the development of the area, and therefore considered to be a strategically inconvenient and disadvantageous to its neighboring communities and to Quezon City, as a whole;

name of M.S. Florendo and Sons, Inc. and covered by Transfer Certificate of Title (TCT) No. RT-97874 (57558) of the Registry of Deeds of Quezon City, containing a gross area of thirty four thousand two hundred twenty five (34,225) square meters, more or less, situated along Payatas Road, Barangay Fayatas, Quezon City, is regarded as the most qualified site for the relocation of the existing City Jail, specifically in terms of location and land area;

WHEREAS, pursuant to Section 455 (b) (1) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniany Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

Section 1. The City Mayor, Honorable, Herbert M. Hautista, is hereby authorized to acquire, either through negotiated sale or expropriation, a parcel of land identified as Lot 113-B-3, PSD-10809, covered by Transfer Certificate of Title (TCT) No. RT-97874 (57558) containing a gross area of Thirty Four Thousand Two Hundred Twenty Five (34,225) Square Meters, more or less, registered under the name of M.S. Florendo and Sons, Inc., located along Payatas Road, Barangay Payatas, Queson City, purposely to be utilized and developed as the site of the new Quezon City Jail.

Section 2. An amount equivalent to the fair market value, based on the current tax declaration of the property to be acquired, or so much thereof as may be necessary for the purpose, is hereby allocated out of the City's General Fund.

Section 3. The Quezon City Engineering Department, in coordination with the other line agencies, shall take charge in the development of the subject property.

Section 4. This ordinance shall take effect upon its approval.
