

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF NARRA HILLSVILLE II HOMEOWNERS ASSOCIATION, INC. WITH NINETY EIGHT (98) SALEABLE LOTS CONTAINING AN AREA OF FOUR THOUSAND SIX HUNDRED FORTY TWO (4,642) SQUARE METERS LOCATED AT LOT 5-B, PSD-00-071310, NARRA STREET, AREA B, BARANGAY PAYATAS, QUEZON CITY, REGISTERED IN THE NAME OF MANILA INC. AND COVERED BY TRANSFER REMNANT CO., TITLE NUMBER N-295638 OF THE CERTIFICATE OF REGISTRY OF DEEDS OF QUEZON CITY, WITH A TOTAL AREA Of SIX THOUSAND SEVEN HUNDRED SEVENTY SEVEN FORANDAS APPLIED METERS (6,777) SQUARE REPRESENTED BY ITS HOA PRESIDENT, MERLINDA F. MIOLE, WITH OFFICE ADDRESS AT THE SAME PROJECT LOCATION, AS VARIANCE PURSUANT TO SECTION 9, RULE III OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF BATAS PAMBANSA BILANG 220.

SECTION 1.
