ORDINANCE NO. SP- **2669**, S-2018

AN ORDINANCE NAMING THE STREETS, OPEN SPACES, PARKS, BUILDINGS, AND HALLS WITHIN THE QUEZON CITY HALL COMPOUND AFTER THE NAMES OF FORMER MAYORS, VICE MAYORS AND COUNCILORS OF QUEZON CITY, WHO PASSED AWAY FOR MORE THAN TEN (10) YEARS.

WHEREAS, to guide the city officials, employees, visitors, and the transacting public about their location and the places and offices they desire to go, there is a need to provide names for the streets, open spaces, parks, buildings, and halls within Quezon City Hall Compound;

WHEREAS, in honor of the former Mayors, Vice Mayors and Councilors of Quezon City and in recognition of their valuable contribution for the city's development, it is but fitting to name the aforesaid places and edifices after their appellations.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The streets, open spaces, parks, buildings, and halls within the Quezon City Hall Compound shall be named after the names of the former Mayors, Vice Mayors and Councilors of Quezon City, who passed away for more than ten (10) years.

SECTION 2. The names of the former Mayors shall be preferred in the naming of streets, buildings and parks.

SECTION 3. The Department of Engineering, in consultation with the General Services Department, shall be responsible in the preparation of the Vicinity Map/Plan and the installation of the necessary Signage and Directional Signs. γ


SECTION 4. The term of office or length of service of the named former Mayors, Vice Mayors and Councilors shall be indicated underneath the signage.

SECTION 5. The provisions of Ordinance No. SP-2462, S-2015 which are applicable in this ordinance shall form an integral part hereof.


SECTION 6. For this purpose, Quezon City Ordinance No. SP-847, S-99 is hereby repealed.

SECTION 7. This Ordinance shall take effect immediately upon its approval.




