AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF DR. D. PASCUAL HOMEOWNERS ASSOCIATION, INC., WITH FIFTY SEVEN (57) SALEABLE LOTS LOCATED AT LOT 18, (LRC) PCS-5936, RIVERA COMPOUND, BARANGAY KALIGAYAHAN, NOVALICHES, QUEZON CITY, REGISTERED IN THE NAME OF DR. D. PASCUAL HOMEOWNERS ASSOCIATION, INC., AND COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 004-2010007629 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF TWO THOUSAND (2,000) SQUARE METERS AS APPLIED FOR AND REPRESENTED BY ITS HOA PRESIDENT, MS. 
