AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF THE PROPOSED ALCOVE RESIDENTIAL SUBDIVISION WITH NINETY-FOUR (94) SALEABLE LOTS LOCATED AT BLOCK 7 PCS-13-002303, E. G. FERNANDEZ CORNER DON PEPE STREETS PALMERA HOMES SUBDIVISION, BARANGAY STA. MONICA, DISTRICT 5, QUEZON CITY, METRO MANILA, REGISTERED IN THE NAME OF KOMMUNO PROPERTIES, INC. AND COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 004-2018009794 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONSISTING AN AREA OF FIFTEEN THOUSAND (15,000) SQUARE METERS, AS REPRESENTED BY ITS PRESIDENT, MA.
