ORDINANCE NO. SP- 2801, S-2018

AN ORDINANCE IMPLEMENTING A ONE-WAY TRAFFIC SCHEME FROM THE CORNER OF ERMIN GARCIA AND ALBANY STREETS TO THE CORNER OF ERMIN GARCIA STREET AND 15TH AVENUE, BARANGAY SILANGAN, QUEZON CITY FROM 6:00 AM TO 8:00 PM, TO EASE TRAFFIC CONGESTION ALONG THE INTERSECTION OF ERMIN GARCIA STREET, KALAYAAN ROAD AND MIAMI STREET, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 16 of the Local Government Code of 1991 provides that:

"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient governance, and those which are essential to the promotion of the general welfare. Within their respective jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced

ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of these inhabitants”;

WHEREAS, the Barangay Government of Barangay Silangan passed a Barangay Resolution entitled, “A Resolution implementing a new traffic scheme from the corner of Ermin Garcia and Albany Streets, One-Way going to Ermin Garcia Street corner 15th Avenue from 6:00 AM to 8:00 PM to ease traffic congestions at the intersection of Ermin Garcia Street, Kalayaan Road and Miami Street”;

WHEREAS, according to the Department of Public Order and Safety (DPOS), the Quezon City authorities assigned in the area, related traffic schemes for the purpose of decongesting traffic that were already initiated therein proved to be effective. In implementing the new traffic scheme, traffic will be re-directed for vehicles coming from New York Street, going to Kalayaan new route by turning right at 15th Avenue, then turning left at Columbia Street, and then taking a left turn at Albany on the way to Ermin Garcia Street.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. This Ordinance shall be known as the “One Way Traffic Ordinance of Ermin Garcia Street, Barangay Silangan, District III, Quezon City”.

SECTION 2. It is hereby declared a one-way traffic scheme from the corner of Ermin Garcia and Albany Streets going to Ermin Garcia Street corner 15th Avenue, from 6:00 AM to 8:00 PM.

SECTION 3. Implementing Rules and Regulations – The Department of Public Order and Safety (DPOS) of Quezon City shall formulate and issue the necessary Rules and Regulations for the effective implementation of this Ordinance. X


SECTION 4. Violation of Section 2 of this Ordinance shall be penalized by the following:


SECTION 6. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon its approval.




