ORDINANCE NO. SP- 2810, S-2019

AN ORDINANCE AMENDING RESOLUTION NO. SP-7411, S-2018 BY WAY OF APPROPRIATING THE AMOUNT OF ONE MILLION FIVE HUNDRED NINETY-TWO THOUSAND PESOS (PHP1,592,000.00), OR SO MUCH THEREOF, FOR THE PURCHASE OF ONE (1) UNIT OF MOTOR VEHICLE TO BE USED BY THE OFFICE OF COUNCILOR ALLAN BUTCH T. FRANCISCO, 5TH DISTRICT, QUEZON CITY, TO BE TAKEN FROM THE FUNDS OF THE SAME OFFICE UNDER THE MOTOR VEHICLE ACCOUNT FOR CY 2017 ANNUAL BUDGET (CONTINUING APPROPRIATION).

WHEREAS, the Office of Councilor Allan Butch T. Francisco is requesting for the purchase of one (1) unit of motor vehicle intended for the monitoring of programs and projects of the said office;

WHEREAS, Resolution No. SP-7411, S-2018 was adopted by the City Council authorizing the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of motor vehicle amounting to (Php1,592,000.00) One Million Five Hundred Ninety-Two Thousand Pesos;

WHEREAS, the Office of Councilor Francisco has complied with all the requirements and submitted the same to the Department of the Interior and Local Government (DILG) and other concerned government offices, but the DILG suggested that instead of a resolution, an appropriation ordinance be enacted and approved for the purpose.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN REGULAR SESSION ASSEMBLED:

SECTION 1. Resolution No. SP-7411, S-2018 is hereby amended to appropriate the amount of One Million Five Hundred Ninety-Two Thousand Pesos (Php1,592,000.00) or so much thereof, for the purchase of one (1) unit motor vehicle to be used for the monitoring of programs and projects of the Office of Councilor Allan Butch T. Francisco, 5th District, Quezon City.

SECTION 2. The amount mentioned in the preceding section shall be charged against the funds of the Office of Councilor Allan Butch T. Francisco under the Motor Vehicle Account for CY 2017, Annual Budget (Continuing Appropriation).

SECTION 3. The City Mayor is hereby authorized to purchase the aforesaid motor vehicle pursuant to DILG memorandum Circular No. 2014-155 dated December 17, 2014 and DBM Circular No. 2017-1 dated April 26, 2017 and other existing laws, rules and regulations, for the use of the Office of Councilor Allan Butch T. Francisco.





SECTION 4. EFFECTIVITY - This Ordinance shall take effect upon approval.




