AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF BISTEKVILLE-15 HOUSING PROJECT WITH SEVEN HUNDRED SEVENTY-SEVEN (777) UNITS LOCATED AT LOT 596-B, (LRC) PSD-99855 AND LOT 554-B-4-D, (LRC) PSD-270021, GENESIS STREET, BARANGAY SAUYO, QUEZON CITY, METRO MANILA REGISTERED IN THE NAME OF THE LOCAL GOVERNMENT OF QUEZON CITY AND COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBER N-004-2015006062 AND 004-2015006063 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF TWENTY THOUSAND FIVE HUNDRED FORTY (20,540) SQUARE METERS, IN COMPLIANCE WITH THE MINIMUM REQUIREMENTS OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF QUEZON CITY ORDINANCE NO. 




