ORDINANCE NO. SP- 2817 , S-2019

AN ORDINANCE DECLARING THE ABANDONED ROAD LOTS, ALLEYS, EASEMENT AND OPEN SPACES OF METROHEIGHTS SUBDIVISION, BARANGAY CULIAT, DISTRICT VI, QUEZON CITY, AS PUBLIC USE PROPERTIES OF THE QUEZON CITY GOVERNMENT PURSUANT TO THE PROVISIONS OF CITY ORDINANCE NO. SP-2298, S-2014, AS CERTIFIED BY THE CITY PLANNING AND DEVELOPMENT OFFICE.

WHEREAS, the Metroheights Subdivision Homeowners Association, Inc., with postal address at Block 1 Lot 2, Andrew Street, Metroheights Subdivision, Barangay Culiat, Quezon City made representations with the Quezon City Government to assist them in declaring their road lots, alleys, easements and open spaces as abandoned and in the process, assist them in the improvements of their community;

WHEREAS, the subdivision developer, Metropolitan Realty and Developers, Inc., failed to turn-over the road lots, alleys, easements and open spaces of the said subdivision to the Quezon City Government;

WHEREAS, the Securities and Exchange Commission (SEC) issued a certification that the registration of Metropolitan Realty and Developers, Inc., was revoked on August 11, 2002 per SEC Order dated July 8, 2003 for failure to submit the required documents to SEC from 1997 to 2002;

WHEREAS, City Ordinance No. SP-2298, S-2014 declared as abandoned roads, alleys, open spaces and excess lots in all subdivisions in Quezon City as properties for public use by the City Government, thereby setting the guidelines for the use thereof and for other purposes;

WHEREAS, on December 11, 2017, the City Planning and Development Office certified that Metroheights Subdivision is an abandoned subdivision pursuant to the provisions of City Ordinance No. SP-2298, S-2014.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Pursuant to the provisions of City Ordinance No. SP-2298, S-2014, it is hereby declared that the abandoned road lots, alleys, easements and open spaces of Metroheights Subdivision located at Barangay Culiat, Quezon City, as public use properties of the Quezon City Government.

SECTION 2. Metroheights Subdivision herein declared as abandoned subdivision shall be subject to the conditions prescribed under City Ordinance No. SP-2298, S-2014.

SECTION 3. The City Mayor, Honorable Herbert M. Bautista, is hereby authorized to cause the repair and maintenance of the road lots, alleys, easements and open spaces of Metroheights Subdivision, Barangay Culiat, Quezon City, which were abandoned by the subdivision developer.

SECTION 4. This Ordinance shall take effect upon its approval.
