ORDINANCE NO. SP- 2821, S-2019

AN ORDINANCE AUTHORIZING THE CITY MAYOR OF QUEZON CITY FOR THE SALE OF A PARCEL OF LAND FORFEITED BY THE CITY THROUGH PUBLIC AUCTION AND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-107844 (60428) OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT BARANGAY TANDANG SORA, IN FAVOR OF QUALIFIED BENEFICIARIES UNDER THE SOCIALIZED HOUSING PROGRAM OF QUEZON CITY.

WHEREAS, the present occupants of the property are requesting the City Government of Quezon City, to dispose and/or sell the same in their favor and introduce development under the Socialized Housing Program;

WHEREAS, it is now necessary for the Quezon City Government to dispose the said property in favor of the qualified beneficiaries of the Socialized Housing Program of Quezon City, to solve the present urban poor dwelling problem of the City in accordance with the provisions of the Local Government Code of 1991 and Republic Act No. 7279, otherwise known as the Urban Development and Housing Act of 1992;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED.

SECTION 1. The 20<sup>th</sup> Quezon City Council authorizes the City Mayor of Quezon City for the sale of a parcel of land forfeited by the City through public auction covered by Transfer Certificate of Title No. RT-107844 (60428) of the Registry of Deeds of Quezon City located at Barangay Tandang Sora, in favor of qualified present occupants under the socialized housing program.

SECTION 2. The Housing, Community Development and Resettlement Department, shall organize, census and qualify all Informal Settler Families (ISF's) occupying the property.
