ORDINANCE NO. SP- **2825**, S-2019

AN ORDINANCE AMENDING ORDINANCE NO. 3559, SERIES OF 1957, ENTITLED "AN ORDINANCE PRESCRIBING THE POWERS AND DUTIES OF THE CITY LIBRARIAN AND SUPERINTENDENT, QUEZON CITY, AND PROMULGATING RULES AND REGULATIONS FOR THE OPERATION THEREOF," AS AMENDED.

WHEREAS, it is the national policy to promote the moral and intellectual well-being of the people;

WHEREAS, Ordinance No. SP-2597, S-2017 has included among the functions of the Quezon City Library and Information Center (QCLIC) the conduct of print and digital publishing services;

WHEREAS, this Ordinance establishes a bookshop offering published books by the QCLIC, and other related items, thereby expanding the services of the QCLIC.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 3 of Ordinance No. 3559, Series of 1957, as amended by Ordinance No. SP-2597, S-2017, is hereby further amended to read as follows:

*(Handwritten signatures and initials)*


"(l) To establish a bookshop offering books and other materials published by the Quezon City Library and Information Center, and other related items promoting Quezon City. The payments collected therein shall accrue under the account created in Section 14."

SECTION 2. SEPARABILITY CLAUSE – If for any reason, any part, section or provision of this Ordinance shall be held invalid or unconstitutional, other provisions or parts thereof not affected thereby shall remain in full force and effect.




SECTION 4. EFFECTIVITY CLAUSE – This Ordinance shall take effect immediately upon its approval.


