AN ORDINANCE ACKNOWLEDGING THE KYUSI EMPLOYEES MULTI-PURPOSE COOPERATIVE (KEMPCO) AS A LEGITIMATE COOPERATIVE MOVEMENT OF QUEZON CITY GOVERNMENT EMPLOYEES.

The State shall encourage the private sector to undertake the actual formation and organization and cooperatives and shall create an atmosphere that is conductive to the growth and development of these cooperatives.

WHEREAS, KEMPCO has its goal to uplift the welfare of the employees of the Quezon City Government by improving the economic well-being of the people;

WHEREAS, KEMPCO is committed to work with government and non-government organizations and stakeholders for the effective and efficient implementation of the provisions of the Cooperative Code;

WHEREAS, KEMPCO has a total number of 2,840 City Hall employees, with a total asset of PHP89,988,164.72 as of August 2018;

WHEREAS, the movement is still striving to work for the enhancement and growth of the cooperative in order to provide more services for the employees of Quezon City.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE - This Ordinance shall be known as "An Ordinance acknowledging the Kyusi Employees Multi-purpose Cooperative (KEMPCO) as a legitimate Cooperative Movement of Quezon City Government Employees

SECTION 2. RULES OF IMPLEMENTATION – This Ordinance shall be interpreted in accordance with the Local Government Code, the Cooperative Code of the Philippines and the Articles of Cooperation and By Laws of the KYUSI Employees Multi-purpose Cooperative (KEMPCO).

SECTION 3. SEPARABILITY CLAUSE – In the event that any portion of Ordinance is declared invalid for reason that some of its provisions may be contrary to any existing policies and laws, the other parts or provisions remaining will not be affected and thereby shall continue to be in full force and effect.

SECTION 4. REPEALING CLAUSE – Other ordinances, implementing rules and regulations inconsistent with this Ordinance are hereby repealed, amended and modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE – This Ordinance shall take effect fifteen (15) days following the completion of its publication in any newspaper of general circulation within Quezon City.
