WHEREAS, Article XIV, Section 1 of the 1987 Philippine Constitution provides that "the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all";

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

WHEREAS, the Local School Board (LSB), through Resolution No. 1, Series of 2018, recommended to establish a Senior High School in Barangay Nagkaisang Nayon, and to name the same as Nagkaisang Nayon Senior High School.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. There is hereby established under the Quezon City Schools Division Office a public high school, located at Barangay Nagkaisang Nayon, to be known as the Nagkaisang Nayon Senior High School.

SECTION 2. The supplemental funds necessary for the construction, maintenance, and operation of the said public school, as determined by the Local School Board, shall be taken from the Special Education Funds of Quezon City or from any available funds of the City.

SECTION 3. In case any provision of this Ordinance is declared unconstitutional or invalid, the other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
