ORDINANCE NO. SP- 3278 , S-2024

AN ORDINANCE ALLOWING ONE-SIDE PARKING ALONG BAYAYA (RIGHT SIDE) AND FULGENCIO STREETS (LEFT SIDE) FROM MILLER STREET TO JUDGE JUAN LUNA STREET, MORQUECILLO STREET (RIGHT SIDE) FROM AGUILAR TO M.H. DEL PILAR STREETS, AND SAMUEL STREET (RIGHT SIDE) FROM MORQUECILLO TO AGUILAR STREETS, BARANGAY BUNGAD, DISTRICT I, QUEZON CITY FROM 6:00 A.M. TO 6:00 P.M., AND PROVIDING PENALTIES FOR VIOLATION THEREOF

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that:

"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, Barangay Bungad, District I, Quezon City passed a Barangay Resolution entitled "A Resolution earnestly requesting the Honorable City Councilor Tany Joe 'TJ' Calalay, First District of Quezon City to enact a City Ordinance entitled 'One-Side Parking in Certain Streets in Barangay Bungad, Quezon City and to provide corresponding penalties to violators'";

WHEREAS, the use of both sides of the streets for parking creates traffic congestions leading to unnecessary delays and time and resource loss;

WHEREAS, the irresponsible parking of vehicles on both sides of the streets even on driveways, especially by non-residents of Barangay Bungad, adversely affects the residents;

WHEREAS, the Sanggunian of Barangay Bungad consulted the Traffic and Transportation Management Department (TTMD) of Quezon City, and in response, the TTMD suggested that one-side parking be imposed on the right side of Bayaya, Morquecillo, and Samuel Streets, and on the left side of Fulgencio Street.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. – This Ordinance shall be known as the "One-Side Street Parking of Bayaya, Fulgencio, Morquecillo, and Samuel Streets in Barangay Bungad, Quezon City."

SECTION 2. The following One-Side Parking Scheme is hereby imposed in Barangay Bungad, District I, Quezon City from 6:00 A.M. to 6:00 P.M.:

- a. Bayaya Street Right Side from Miller to Judge Juan Luna Streets;
- b. Fulgencio Street Left Side from Miller to Judge Juan Luna Streets;
- c. Morquecillo Street Right Side from Aguilar to M.H. Del Pilar Streets;
- c. Samuel Street Right Side from Morquecillo to Aguilar Streets.

SECTION 3. IMPLEMENTING RULES AND REGULATIONS. – The TTMD of Quezon City shall formulate and issue the necessary rules and regulations for the effective implementation of this Ordinance.

SECTION 4. Violation of Section 2 of this Ordinance shall be penalized with a fine amounting to:

- Php1,000.00 if the vehicle is attended by the driver; or
- Php2,000.00 and impoundment of the vehicle if the same is unattended by the driver as provided under Section 11 of Ordinance No. SP-3172, S-2023, otherwise known as the Metro Manila Traffic Code of 2023.

SECTION 5. REPEALING CLAUSE. – All ordinances, resolutions, rules and regulations inconsistent with the provision of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE. – This Ordinance shall take effect immediately upon its approval.
