AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF THE SUMMIT HILLS HOMEOWNERS ASSOCIATION, INC., WITH ACOMMUNITY MORTGAGE PROGRAM (CMP) PROJECT OFTHE**OUEZON CITY** GOVERNMENT ORIGINATED WITH THE **HOUSING COMMUNITY** DEVELOPMENT AND RESETTLEMENT DEPARTMENT (HCDRD) AND 24 SALEABLE LOTS LOCATED AT LOTS 27 AND 28, BLOCK 3, CAIMITO STREET, AREA B, BARANGAY PAYATAS, DISTRICT II, QUEZON CITY, METRO MANILA, REGISTERED IN THE NAMES OF LOURDES OFIANA SANSON, ET AL. AND BRENDA RUTH A. ANGELES COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERS 004-2013013442 AND N-202561 OF THE REGISTRY OF DEEDS FOR QUEZON CITY, CONSISTING AN AGGREGATE AREA OF 844.00 SQUARE METERS, AS REPRESENTED BY ITS HOA PRESIDENT, MR. SECTION 1.
