AN ORDINANCE APPROVING THE ALTERATION OF THE SUBDIVISION PLAN OF BISTEKVILLE V (SOCIALIZED HOUSING PROJECT) FROM 204 TO 206 SALEABLE LOTS (INCREASED BY 2 LOTS) LOCATED AT LOTS 12-A AND 12-C, PSD-00-089607, MADJA-AS ROAD CORNER PAYATAS (LITEX) ROAD, BARANGAY PAYATAS, DISTRICT II, QUEZON CITY, METRO MANILA, REGISTERED IN THE NAME OF THE CITY GOVERNMENT OF QUEZON CITY COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERS 004-2016001645 AND 004-2016001647 OF THE REGISTRY OF DEEDS FOR QUEZON CITY, CONSISTING AN AGGREGATE AREA OF 10,900 SQUARE METERS, AS REPRESENTED BY HOA SECRETARY, MYRA L. GUMABAO, WITH OFFICE ADDRESS AT THE SAME PROJECT LOCATION, IN COMPLIANCE WITH THE MINIMUM REQUIREMENTS, OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF BATAS PAMBANSA BILANG 220

SECTION 1.
