WHEREAS, Administrative Order No. 316, S-1997 signed by then President Fidel V. Ramos, states that:

*“NOW, THEREFORE, I, FIDEL V. RAMOS, President of the Republic of the Philippines, by virtue of the power vested in me by law, do hereby order the extension of the grant of milestone Anniversary Bonus authorized under Administrative Order No. 263, dated March 28, 1996 to officials and employees in local government units, in accordance with rules and regulations to be issued for the purpose by the Department of Budget and Management. As defined under item 2.4 thereof, a milestone year refers to the 15<sup>th</sup> Anniversary and to every fifth year thereafter.”*

*WHEREAS, as we celebrate this milestone in our City, it is fitting and proper that we acknowledge the hardworking people, employees, regardless of status, who make the wheel of service work for our constituents and our City, making Quezon City a prime City;*

*WHEREAS, the grant of Anniversary Bonus on October 12, 2024, as authorized under existing laws, rules and regulations, showcases the gratitude of the Quezon City Government to its employees.*

*NOW, THEREFORE,*

*BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:*

*SECTION 1. An Anniversary Bonus is hereby granted to all employees in the amount of Php3,000.00 on the occasion of the celebration of the 85<sup>th</sup> Foundation Day Anniversary of Quezon City.*

*SECTION 2. There is hereby appropriated the amount of Php50,000,000.00 or so much thereof as may be necessary for the purpose, out of the funds of the City Treasurer’s Office not otherwise appropriated for any other purpose.*
