ORDINANCE

GRANTING FINANCIAL ASSISTANCE TO THE FAMILIES OF THE LATE SPO4 ROGELIO TAPAN, PO3 REYNOSO BACNOT AND PO3 RENATO ZAFRA, ALL MEMBERS OF THE PHILIPPINE NATIONAL POLICE ASSIGNED TO THE CENTRAL POLICE DISTRICT COMMAND, WHO DIED IN LINE OF DUTY ON JULY 13, 1992 DURING A SNEAK ATTACK PERPETRATED BY LAWLESS ELEMENTS ON THE SAME DATE AT SUB-STATION 2, STATION 2, NOVALICHES, QUEZON CITY, IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) FOR EACH OF THEIR RESPECTIVE IMMEDIATE FAMILY, AND AUTHORIZING THE AMOUNT OF P150,000.00 TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE OFFICE OF THE CITY MAYOR IN THE 1992 ANNUAL BUDGET, SUBJECT TO USUAL AUDITING RULES AND REGULATIONS.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:
