ORDINANCE

INCREASING THE INCENTIVE ALLOWANCE OF THE FIFTY (50) INQUEST PROSECUTORS OF THE OFFICE OF THE CITY PROSECUTOR, QUEZON CITY FROM ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) TO TWO THOUSAND FIVE HUNDRED PESOS (P2,500.00) FROM JULY 1, 1993 TO DECEMBER 31, 1993, AND ALLOCATING THE SUM OF THREE HUNDRED THOUSAND PESOS (P300,000.00) FROM THE APPROVED LUMP SUM APPROPRIATION OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) UNDER THE INTER-AGENCY COMMITTEE ON JUSTICE IN QUEZON CITY UNDER THE SPECIAL PROJECTS OF THE OFFICE OF THE MAYOR, PURSUANT TO EXECUTIVE ORDER NO. 2, S-92.

WHEREAS, Section 458 of Republic Act. No. 7160 otherwise known as Local Government Code of 1991 provides, among others:

"SEC. 458. Powers, Duties, Functions and Compensation.

a) The Sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:
