ORDINANCE NO. SP-102, S-93

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO MR. RODRIGO A. GOMEZ, A CASUAL EMPLOYEE UNDER THE THE ANTI-SQUATTING SURVEILLANCE AND ENFORCEMENT TEAM (ASSET), OFFICE OF THE CITY MAYOR, QUEZON CITY, WHO SUSTAINED AND SUFFERED GUNSHOT WOUND AS MEMBER OF A DEMOLITION TEAM ON APRIL 2, 1993, IN THE AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 1993 BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.
