ORDINANCE NO. SP-147, S-93

AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR CALENDAR YEAR 1994 IN THE TOTAL AMOUNT OF TWO BILLION EIGHT HUNDRED FORTY-SEVEN MILLION THREE HUNDRED NINETY-FOUR THOUSAND EIGHT HUNDRED AND EIGHTEEN PESOS (P2,847,394,818.00) COVERING THE VARIOUS EXPENDITURES OF THE CITY GOVERNMENT FOR THE YEAR 1994, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Annual Budget of the Quezon City Government for Calendar Year 1994 in the total amount of TWO BILLION EIGHT HUNDRED FORTY-SEVEN MILLION THREE HUNDRED NINETY-FOUR THOUSAND EIGHT HUNDRED AND EIGHTEEN PESOS (P2,847,394,818.00) covering the various expenditures of the City Government for the year 1994 is hereby approved.

The budget documents are hereby made as integral part of this ordinance.

SECTION 2. There is hereby appropriated from the General Fund the sum of TWO BILLION EIGHT HUNDRED FORTY-SEVEN MILLION THREE HUNDRED NINETY-FOUR THOUSAND EIGHT HUNDRED AND EIGHTEEN PESOS (P2,847,394,818.00) or so much thereof as may be necessary, to be made
