ORDINANCE NO. SP-164, S-94

AN ORDINANCE AUTHORIZING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR. TO NEGOTIATE WITH THE OWNER OF INITIATE AN EXPROPRIATION PROCEEDING FOR THE ACQUISITION OF A PARCELS OF LAND LOCATED IN KAINGIN, BARANGAY APOLONIO SAMSON, BALINTAWAK, QUEZON CITY, CONSISTING OF ONE THOUSAND FOUR HUNDRED (1,400) SQUARE METERS AND COVERED BY TCT NO. 96703 OF THE REGISTRY OF DEEDS OF QUEZON CITY TO BE EXCLUSIVELY USED AS A PERMANENT SITE OF THE PUBLIC ELEMENTARY SCHOOL IN THE AREA, AND ALLOCATING THE NECESSARY FUNDS FOR THE PURPOSE, THE AMOUNT OF WHICH SHALL BE DETERMINED BY THE QUEZON CITY APPRAISAL COMMITTEE, TO BE TAKEN FROM THE FUNDS OF THE LOCAL SCHOOL BOARD FOR THE BUDGET CALENDAR YEAR 1994.
