ORDINANCE NO. SF-270, 1-94

AN ORDINANCE AMENDING ORDINANCE NO. SF-113, S-93, AN ORDINANCE DIRECTING THE QUEZON CITY ZONING REVIEW COMMITTEE, AS PROVIDED IN THE IMPLEMENTING RULES AND REGULATIONS OF ORDINANCE NO. SF-22, S-92, OTHERWISE KNOWN AS THE QUEZON CITY ZONING ORDINANCE OF 1992, TO REVIEW THE EXISTING ZONING CLASSIFICATION AND/OR ZONING BOUNDARIES OF QUEZON CITY AND TO DRAFT AND SUBMIT TO THE CITY COUNCIL FOR APPROVAL ITS RECOMMENDATION FOR REZONIFICATION, AND ALLOCATING THE NECESSARY FUNDS THEREFOR.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 3 of Ordinance No. SF-113, S-93 entitled "AN ORDINANCE DIRECTING THE QUEZON CITY ZONING REVIEW COMMITTEE, AS PROVIDED IN THE IMPLEMENTING RULES AND REGULATIONS OF ORDINANCE NO. SF-22, S-92, OTHERWISE KNOWN AS "THE QUEZON CITY ZONING ORDINANCE OF 1992" TO REVIEW THE EXISTING ZONING CLASSIFICATION AND/OR ZONING BOUNDARIES OF QUEZON CITY AND TO DRAFT AND SUBMIT TO THE CITY COUNCIL FOR APPROVAL ITS RECOMMENDATION FOR REZONIFICATION, AND PROVIDING THE NECESSARY FUNDS THEREFOR", is hereby amended to read as follows:

" SECTION 3. There is hereby allocated for the purpose the amount of FIVE MILLION PESOS (P5,000,000.00) TO BE TAKEN FROM THE SPECIAL PROJECTS FUND OF THE OFFICE OF THE MAYOR UNDER THE 1994 EXECUTIVE BUDGET, broken down as follows:

- A. PERSONAL SERVICES
  - 1. Wages for 45 contractual employees P1,535,490.00
  - 2. LIVING ALLOWANCE FOR CONTRACTUAL EMPLOYEES 247,500.00
