ORDINANCE NO. SP-255, S-94

AN ORDINANCE APPROVING THE SUBDIVISION PLAN WITH VERTICAL COMPONENT OF LOT 22, BLOCK 14 (LRC) PCS-13293 (LLANAR HOMES) LOCATED AT IRIS STREET CORNER DAFFODIL STREET, WEST FAIRVIEW, QUEZON CITY, CONTAINING AN AREA OF SEVEN HUNDRED SIXTY-ONE (761.00) SQUARE METERS, COVERED BY TCT NO. 63206 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AS SUBMITTED BY LLANAR PROPERTIES, INC., REPRESENTED BY FILOMENA NARANJILLA OF 135 MAGINHAWA ST., SIKATUNA VILLAGE, QUEZON CITY, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER ORDINANCE NOS.
