ORDINANCE NO. SP-278, S-95

AN ORDINANCE APPROVING THE CONSOLIDATION-SUBDIVISION PLAN OF LOTS 5-D AND 5-E, PSD-24136 (LIZARDO TENANTS, RESIDENTS AND HOMEOWNERS ASSOCIATION, INC.), CONTAINING AN AREA OF ONE THOUSAND FIVE HUNDRED EIGHTEEN (1,518.00) SQUARE METERS, COVERED BY TCT NO. RT-90167 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SOLOMON A. LIZARDO, LOCATED AT LIZARDO ST., 20TH AVENUE, BARANGAY DIOQUINO-ZOBEL, QUEZON CITY, AS APPLIED FOR BY THE LIZARDO TENANTS, RESIDENTS AND HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY ELVIRA B. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN SESSION ASSEMBLED:

SECTION 1. The Subdivision-Consolidation Plan of Lots 5-D and 5-E, Psd-24136 (Lizardo Tenants, Residents and Homeowners Association, Inc.), containing an area of One Thousand Five Hundred Eighteen (1,518.00) Square Meters, covered by TCT No. RT-90167 of Solomon A. Lizardo, located at Lizardo Street, 20th Avenue, Barangay Dioquino-Zobel, Quezon City, as applied for by the Lizardo Tenants, Residents and Homeowners Association, Inc., represented by Elvira B.
