ORDINANCE NO. SP-306, S-95

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LOT 873-A-1, PSD-13-018847 (KABALIKAT SA KAUNLARAN NEIGHBORHOOD ASSOCIATION, INC.) CONTAINING AN AREA OF FIVE THOUSAND (5,000) SQUARE METERS, COVERED BY TCT NO. 97351 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF KABALIKAT SA KAUNLARAN NEIGHBORHOOD ASSOCIATION, INC., AND LOCATED AT BARANGAY SAUYO, QUEZON CITY, AS APPLIED FOR BY MS. SECTION 1.
