ORDINANCE NO. SP-309, S-95

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LOTS 12, 15, 16, & 17, PCS-2587 (VISTA REAL PHASE I-E) COVERED BY TCT NOS. 96750, 48855, 58171 AND 46423 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF THIRTY-THREE THOUSAND NINE HUNDRED FIFTY-SIX (33,956.00) SQUARE METERS SITUATED IN BARANGAY MATANDANG BALARA, DILIMAN, QUEZON CITY, AS APPLIED FOR BY STA. LUCIA REALTY AND DEVELOPMENT, INC. REPRESENTED BY WINIFRED G. GOB, G/F STATE FINANCING CENTER BUILDING, ORTIGAS AVENUE, MANDALUYONG CITY, METRO MANILA, IN CONFORMITY WITH THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF QUEZON CITY ORDINANCE NO.
