ORDINANCE NO. SP-345, S-95

ORDINANCE APPROVING RESOLUTION NO. 04, S-94 OF THE BOARD OF APPEALS ON THE APPEALS FOR RECTIFICATION OF POSITION TITLES AND/OR SALARY GRADES OF AGGRIEVED EMPLOYEES OF THE QUEZON CITY GOVERNMENT PURSUANT TO R.A. 6758, OTHERWISE KNOWN AS THE "COMPENSATION AND POSITION CLASSIFICATION ACT", AND ALLOCATING THE NECESSARY AMOUNT FOR THE PURPOSE THEREOF.

WHEREAS, the City Council of Quezon City has passed and adopted on December 9, 1993 Resolution No. SP-199, S-93, which provides in part:

"The City Council, cognizant of the injustice done to these employees, is now contemplating to take remedial action by creating a Board of Appeals whose main task is to hear and act on all matters of upgrading, reclassification, etc., of employees in the Quezon City Government, affected by the salary standardization law."

WHEREAS, the Board of Appeals, created in the aforementioned City Resolution, has favorably recommended the approval of certain appeals and/or request of aggrieved city government employees after thorough study of the facts surrounding the request and careful evaluation and consideration of the merits and propriety involved therein.

WHEREAS, the City Council has the power to approve Ordinances necessary for the efficient and effective operation and management of the City Government.
