ORDINANCE NO. SP- 468, S-96

AN ORDINANCE AMENDING ORDINANCE NO. SP-388, S-96, APPROPRIATING THE AMOUNT OF FOUR MILLION FIVE HUNDRED SEVENTY-EIGHT THOUSAND AND NINE HUNDRED PESOS (P4,578,900.00) TO BE USED IN THE CONDUCT OF SANGGUNIANG KABATAAN ELECTIONS, BY REPROGRAMMING AND ADJUSTING SAID AMOUNT OF APPROPRIATIONS PROVIDED FOR IN SECTION 1, ANNEX "A" THEREOF.

WHEREAS, on March 14, 1996, Ordinance No. SP-388, S-96, was enacted by the City Council, entitled, as follows:

"An Ordinance appropriating the amount of four million five hundred seventy-eight thousand and nine hundred pesos (P4,578,900.00) from the Sangguniang Kabataan funds held in trust by the City government for 1996 for the conduct of the Sangguniang Kabataan Election to be held on May 6, 1996, and for other purposes."

WHEREAS, attached therewith and made integral part thereof was Annex "A", specifying therein the budgetary requirements prepared by Atty. Crispin C. Gonzales, Supervising City Election Officer, Quezon City COMELEC Office, dated March 7, 1996;

WHEREAS, the actual expenditures incurred in the conduct of the Sangguniang Kabataan election held on May 6, 1996, was lower than what was appropriated and programmed during the approval of Ordinance No. SP-388, S-96;

WHEREAS, the four (4) District Election Officers of Quezon City, COMELEC, submitted its recommendation for the reprogramming of the funds appropriated in the aforementioned ordinance to the City Mayor, who in turn indorsed the same to the City Council;
