ORDINANCE NO. SP- 500, S-97

AN ORDINANCE AUTHORIZING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BARANGAY PINAGKAISAHAN NEIGHBORHOOD ASSOCIATION FOR THE PURPOSE OF GRANTING THE BENEFICIAL USE OF A PARCEL OF LAND COMPRISING A PORTION OF LOT 4C, BLOCK 1-A PCS 754 OF THE SUBDIVISION PLAN ADOPTED BY THE QUEZON CITY COUNCIL WITH AN AREA OF ONE HUNDRED NINETY-FIVE (195) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-30062 (491) AND OWNED BY THE QUEZON CITY GOVERNMENT, FOR ITS MANAGEMENT, MAINTENANCE AND DEVELOPMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Honorable City Mayor is hereby authorized to enter into a Memorandum of Agreement with the Barangay Pinagkaisahan Neighborhood Association, for the purpose of granting the beneficial use of a parcel of land formerly occupied by the Auditor's bodega comprising a portion of Lot 4C, Block 1-A PCS 754 of the subdivision plan adopted by the Quezon City Council with an area of one hundred ninety-five (195) square meters covered by TCT No. RT-30062 (491) and owned by the Quezon City government.

SECTION 2. The Sangguniang Barangay of Barangay Pinagkaisahan, Quezon City shall manage, operate, develop and maintain the said parcel of land;

SECTION 3. A Memorandum of Agreement shall be entered into by and between the City Mayor and the Barangay Pinagkaisahan Neighborhood Association for a period of twenty five (25) years renewable at the option of both parties.
