ORDINANCE NO. SP- 532, S-97

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LOT 6, BLK. 30, (LRC) PSD-9707, (RESIDENTIAL SUBDIVISION : COMMUNITY MORTGAGE PROGRAM), CONTAINING AN AREA OF SEVEN HUNDRED NINETY-EIGHT (798) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO.173818 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SAMAHANG MARALITA NG MALIGAYA HOMEOWNERS ASSOCIATION, INC., LOCATED AT MALIGAYA PARK SUBDIVISION, BARANGAY PASONG PUTIK, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY SAMAHANG MARALITA NG MALIGAYA HOMEOWNERS ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Lot 6, Blk. 30, (LRC) Psd-9707 (Residential Subdivision : Community Mortgage Program), containing an area of Seven Hundred Ninety-Eight (798) square meters, covered by Transfer Certificate of Title No. 173818 of the Registry of Deeds of Quezon City, registered in the name of Samahang Maralita ng Maligaya Homeowners Association, Inc., located at Maligaya Park Subdivision, Barangay Pasong Putik, Novaliches, Quezon City, Metro Manila, as applied for by Samahang Maralita ng Maligaya Homeowners Association, Inc., represented by Mr. Rodrigo C.
