ORDINANCE NO. SP- 531, S-97

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LOTS 3 & 4, BLK. 5, PSD-4785 AND LOT 12, BLK. 1, PSD-4786, (RESIDENTIAL SUBDIVISION: COMMUNITY MORTGAGE PROGRAM), CONTAINING AN AREA OF ONE THOUSAND ONE HUNDRED TWENTY-FOUR (1,124) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-112329, N-144085 AND N-144090 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF MATILDE G. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Lots 3 & 4, Blk. 5, Psd-4785 and Lot 12, Blk. 1, Psd-4786 (Residential Subdivision : Community Mortgage Program), containing an area of One Thousand One Hundred Twenty-Four (1,124) square meters, covered by Transfer Certificates of Title Numbered. RT-112329, N-144085 and N-144090 of the Registry of Deeds of Quezon City, registered in the name of Matilde G.
