ORDINANCE NO. SP- 549, S-97

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LOTS 3, 4, 5, BLOCK 1, (LRC) PSD-10007, (DMI BRICK TOWNHOMES: 15 UNITS), CONTAINING AN AGGREGATE AREA OF ONE THOUSAND TWO HUNDRED (1,200) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 116285, 116286, AND 11633 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF DMI CONSTRUCTION AND LOCATED AT DONA JULIANA ST., CONGRESS PARK SUBDIVISION, FAIRVIEW, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY DIONISIO M. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
SESSION ASSEMBLED:

SECTION 1.
