ORDINANCE NO. SP- 596 , S-97

AN ORDINANCE APPROVING THE RESIDENTIAL SUBDIVISION PLAN OF LOT 215, FLS-2696-D : BP 220 MODEL 'E' (17 LOTS), CONTAINING AN AREA OF NINE HUNDRED TWENTY (920) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-135923 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF THE SAMAHANG MAGKAKAPITBAHAY NG JOAN OF ARC HOMEOWNERS ASSOCIATION, INC., LOCATED AT JOAN OF ARC AND TATLONG HARI STREETS, JOAN OF ARC, BARANGAY SAN BARTOLOME, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHANG MAGKAKAPITBAHAY NG JOAN OF ARC HOMEOWNERS ASSOCIATION, INC., (VENDEE), SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The residential subdivision plan of lot 215, FLS-2696-D : BP 220 Model 'E' (17 lots), containing an area of Nine Hundred Twenty (920) square meters, covered by Transfer Certificate of Title No. N-135923 of the Registry of Deeds of Quezon City, registered in the name of the Samahang Magkakapitbahay ng Joan of Arc Homeowners Association, Inc., located at Joan of Arc and Tatlong Hari Streets, Joan of Arc, Barangay San Bartolome, Novaliches, Quezon City, Metro Manila, as applied for by the Samahang Magkakapitbahay ng Joan of Arc Homeowners Association, Inc., is hereby approved, subject to the conditions prescribed under Quezon city Ordinance No. SP-56, S-92 and Batas Pambansa Blg. 220, details of which are as follows:
