ORDINANCE NO. SP- 611, S-98

AN ORDINANCE INCREASING THE PRICE OF MOVIE TICKETS IN ALL THEATERS AND CINEMA HOUSES IN QUEZON CITY BY ONE PESO (P1.00) ONLY FOR THE ENTIRE MONTH OF FEBRUARY 1998 AND APPROPRIATING THE PROCEEDS THEREOF TO THE QUEZON CITY CHAPTER OF THE PHILIPPINE NATIONAL RED CROSS AS A MANIFESTATION OF SUPPORT TO ITS HUMANITARIAN ENDEAVORS FOR THE PEOPLE OF QUEZON CITY FOR THE PAST FIFTY (50) YEARS AND AS A CONTRIBUTION OF THE CHAPTER'S GOLDEN ANNIVERSARY.

WHEREAS, the Quezon City Chapter of the Philippine National Red Cross is requesting the Quezon City government to allow the increase of the price of movie tickets in all theaters and cinema houses in Quezon City during the period February 1 to February 28, 1998, by one peso (P1.00) in celebration of the Chapter's Golden Anniversary;

WHEREAS, the proceeds of said increase by One Peso (P1.00) will go to the Quezon City Chapter of the Philippine National Red Cross so as to augment its financial resources that will be utilized in the continuance of its community-based development projects;

WHEREAS, such request was formally made through a resolution of the Quezon City Chapter of the Philippine National Red Cross adopted on the 27th day of January 1998 in celebration of its 50th Anniversary;

WHEREAS, the Sangguniang Panlungsod, pursuant to the Local Government Code of 1991, has the power to regulate the establishment, operation and maintenance of any entertainment or amusement facilities;
