AN ORDINANCE APPROVING THE RESIDENTIAL SUBDIVISION PLAN CONTAINING AN AREA OF NINE HUNDRED FOURTEEN (914) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO.
