AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL SUBDIVISION WITH FIFTY-ONE (51) LOTS, CONTAINING AN AREA OF TWO THOUSAND NINE HUNDRED THIRTY-EIGHT (2,938) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-107506 (54385) OF THE REGISTRY OF DEEDS OF QUEZON CITY REGISTERED IN THE NAME OF FLORENCIO R. TANDOC (VENDOR), AND LOCATED AT LOTS 2 AND 3, FLS-2592-D, SAN NICASIO STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY, AS APPLIED FOR BY TANDOC PROPERTY URBAN POOR HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY MR.
