AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL SUBDIVISION WITH SEVENTEEN (17) LOTS, CONTAINING AN AREA OF FIVE HUNDRED TWENTY-ONE (521) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-81743 (135346) OF THE REGISTRY OF DEEDS OF QUEZON CITY REGISTERED IN THE NAME OF SERAFIN I. RAVASCO (VENDOR), AND LOCATED AT LOT 847-B-2-D (LRC) PSD-57016, MAGSAYSAY AVE., DOÑA FAUSTINA SUBDIVISION, BARANGAY SAN BARTOLOME, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY FAUSTINA KARATIG-II HOMEOWNERS ASSOCIATION, INC. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:
