ORDINANCE NO. SP-707 S-98

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF FAIRVIEW PARK HOMES (PHASE II, STAGE II) : TWO-STOREY TOWNHOUSES WITH EIGHTY-NINE (89) UNITS, CONTAINING AN AGGREGATE AREA OF SEVEN THOUSAND AND SEVEN (7,007) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-33099, RT-33149, RT-32428, RT-33162, RT-32929, RT-32932, RT-32933, RT-32524, RT-32526 & RT-32528 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF THE GOVERNMENT SERVICE INSURANCE SYSTEM, AND LOCATED AT LOTUS STREET, MAGNOLIA CORNER TITUS STREETS, IRIS STREET, NARCISUS STREET, DIAMOND STREET AND HILLMAN STREET, FAIRVIEW SUBDIVISION, QUEZON CITY, AS APPLIED FOR BY THE GOVERNMENT SERVICE INSURANCE SYSTEM, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of Fairview Park Homes (Phase II, Stage II) Two-Storey Townhouses (89 units), containing an aggregate area of Seven Thousand and Seven (7,007) square meters, covered by Transfer Certificates of Title Numbered RT-33099, RT-33149, RT-32428, RT-33162, RT-32929, RT-32932, RT-32933, RT-32524, RT-32526 & RT-32528 of the Registry of Deeds of Quezon City, registered in the name of the Government Service Insurance System, and located at Lotus Street, Magnolia corner Titus Streets, Iris Street, Narcisus Street, Diamond Street and Hillman Street, Fairview Subdivision, Quezon City, as applied for by the Government Service Insurance System, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93, details of which are as follows:
