AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL SUBDIVISION (BATAS PAMBANSA BLG. 220) WITH SEVENTEEN (17) LOTS UNDER THE COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SEVEN HUNDRED (700) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 57571, OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SPOUSES SIMEON CASTRO AND ANGELA CASTRO, AND LOCATED AT LOT NO 886-D-2-A-2, PSD-007404-021028-D, CASTRO STREET, BARANGAY STA. LUCIA, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE PEOPLE'S NEIGHBORHOOD ASSOCIATION, INC, REPRESENTED BY MS. MABEL C. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a Residential Subdivision (Batas Pambansa Blg. 220) with seventeen (17) lots under the Community Mortgage Program, containing an area of Seven Hundred (700) square meters covered by Transfer Certificate of Title No. 57571 of Registry of Deeds of Quezon City, registered in the name of Spouses Simeon Castro and Angela Castro, and located at Lot No-886-D-2-A-2, Pscd-007404-021028-D, Castro St., Brgy.
