Ordinance No. SP-743, S-1998

AN ORDINANCE AMENDING SP-600, AS AMENDED, RE-PROGRAMMING THE EIGHT MILLION PESOS AUTHORIZED UNDER RESOLUTION NO. SP-977, SERIES OF 1998 (BEFORE THE IMPLEMENTATION OF THE QUEZON CITY COUNCIL'S COMPUTERIZATION PROGRAM [SECOND PHASE]) FOR PURPOSES OF SOCIO ECONOMIC PROGRAMS.

WHEREAS, a lump sum appropriation in the amount of **EIGHT MILLION PESOS (P8,000,000.00)** has been provided in the 1998 Annual Budget for the completion of the City Council's program;

WHEREAS, Resolution No. **SP-1050, S-98**, was adopted by the Quezon City Council holding in abeyance the implementation of the Quezon City Council's Computerization Program (Second Phase) and re-programming the appropriation provided for in Resolution No. **SP-977** for socio economic projects;

WHEREAS, there is a need to re-program the said appropriation due to the present economic crises faced by the country and the residents of Quezon City in favor of socio-economic program and projects.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

Section 1. The Eight Million Pesos (P8,000,000.00) authorized under **SP-977, S-98** for the completion of the computerization of the City Council is hereby re-programmed for the immediate implementation of socio-economic programs and projects for the people of Quezon City.

Section 2. The City Vice Mayor is hereby authorized to enter into any contract for the immediate implementation of the programs mentioned in Section 1 hereof.
