ORDINANCE NO. SP-758 - S-99

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A 3-STOREY TOWNHOUSE PROJECT (10-UNITS), CONTAINING AN AREA OF EIGHT HUNDRED SEVENTY-SEVEN AND 30/100 (877.30) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-174481, OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF ROEL D. FELICIANO, AND LOCATED AT LOT 3, BLOCK 30, PSD-35337, NO. 40 NICANOR REYES STREET, BARANGAY LOYOLA HEIGHTS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY ROEL D. FELICIANO, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-92 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:
