ORDINANCE NO. SP- 874 - , S-99

AN ORDINANCE AUTHORIZING THE PRESIDING OFFICER TO AUGMENT THE FUNDS APPROPRIATED FOR SPECIAL PROJECTS OF THE CITY COUNCIL IN THE AMOUNT OF TWO MILLION FIVE HUNDRED SIXTY-FIVE THOUSAND PESOS (P2,565,000.00) TO BE TAKEN FROM THE LUMP SUM APPROPRIATION FOR THE MAINTENANCE AND OTHER OPERATING EXPENSES OF SECTORAL REPRESENTATIVES WHICH IS OF THE SAME EXPENSE CLASS.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Honorable Presiding Officer and City Vice-Mayor is hereby authorized to augment the funds appropriated for Special Projects of the City Council in the amount of Two Million Five Hundred Sixty-Five Thousand Pesos (P2,565,000.00) to be taken from the Lump Sum Appropriation for the Maintenance and Other Operating Expenses of Sectoral Representatives which is of the same expense class.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
