ORDINANCE NO. SP- 853, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH TWENTY (20) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF EIGHT HUNDRED (800) SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED 35556 AND 76611 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF LEOPOLDO L. ASIBAL AND NELSON G. ASAYTONO, RESPECTIVELY, AND LOCATED AT UPPER BANLAT, BARANGAY TANDANG SORA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE MAHARLIKA HILLS HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY MS. MATILDE V. MONTANCES, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a RESIDENTIAL HOUSING PROJECT (BP Blg. 220) with twenty (20) lots, Community Mortgage Program, containing an area of Eight Hundred (800) square meters, covered by Transfer Certificates of Title Numbered 35556 and 76611 of the Registry of Deeds of Quezon City, registered in the name of Leopoldo L. Asibal and Nelson G. Asaytono, respectively, and located at Upper Banlat, Barangay Tandang Sora, Quezon City, Metro Manila, as applied for by the Maharlika Hills Homeowners Association, Inc., represented by Ms. Matilde V. Montances, is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are as follows:
