AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH FORTY (40) LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND SIX HUNDRED FIFTY-THREE (1,653) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-69950 (282810), OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF EUSEBIA S. BARCELON ET. AL., AND LOCATED AT LOT NO. 735-Q, FLS-2568-D, KABAGONG TAUHAN ST., BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY SAMAHANG MARALITA NG KABAGONG TAUHAN HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY MR. ROBERTO M. ARIATE, UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Subdivision Plan of a RESIDENTIAL HOUSING PROJECT (BP Blg. 220) with Forty (40) lots, Community Mortgage Program, containing an area of One Thousand Six Hundred Fifty Three (1,653) square meters, covered by Transfer Certificate of Title No. RT-69950 (282810) of the Registry of Deeds of Quezon City, registered in the name of Eusebia S. Barcelon et al., and located at Lot No. 735-Q, Fls-2568-D, Kabagong Tauhan St., Barangay Gulod, Novaliches, Quezon City, Metro Manila, as applied for by the Samahang Maralita ng Kabagong Tauhan Homeowners Association, Inc., represented by Mr. Roberto M.
