AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL HOUSING PROJECT (BP BLG. 220) WITH ONE HUNDRED NINETY-THREE (193) LOTS COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF TEN THOUSAND FIFTY-NINE (10,059) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-89086, OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF BIYAYA CORP. AND LOCATED AT LOT 23, BLOCK 31 (LRC) PSD-9707, ILANG-ILANG ST., MALIGAYA PARK SUBD., BRGY. PASONG PUTIK, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE FIRST MALIGAYA HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY MRS. LOURDES P. BASAN, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Subdivision Plan of a RESIDENTIAL HOUSING PROJECT (BP Blg. 220) with One Hundred Ninety-Three (193) lots, Community Mortgage Program, containing an area of Ten Thousand Fifty-Nine (10,059) square meters, covered by Transfer Certificate of Title No. RT-89086 of the Registry of Deeds of Quezon City, registered in the name of Biyaya Corp., and located at Lot No. 23 Block 31 (LRC) Psd-9707, Ilang-Ilang St., Maligaya Park Subd., Brgy.
