ORDINANCE NO. 926 - SP-2000.

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF WOODSIDE II HOMES (PH-1); TWO AND THREE-STOREY TOWNHOUSE PROJECT WITH ONE HUNDRED SIXTY-SEVEN (167) UNITS CONTAINING AN AREA OF THIRTY-THREE THOUSAND THREE HUNDRED FORTY-ONE SQUARE METERS AND FIFTY- SEVEN SQUARE DECIMETERS (33,341.57 SQ.M.) COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-144505, N-207679, N-207680 & N-207681 OF THE REGISTRY OF DEEDS OF QUEZON CITY, OWNED BY AYALA LAND, INC., AND LOCATED AT E. RODRIGUEZ SR. AVENUE, BARANGAY KALUSUGAN, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE OWNER, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD-957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of WOODSIDE II HOMES (PH-1); Two and Three-Storey Townhouse Project with One Hundred Sixty-Seven (167) Units containing an area of Thirty-Three Thousand Three Hundred Forty-One Square Meters and Fifty-Seven Square Decimeters (33,341.57 sq.m.) covered by Transfer Certificates of Title Numbered N-144505, N-207679, N-207680 & N-207681 of the Registry of Deeds of Quezon City, owned by AYALA LAND, INC., and located at E.
