ORDINANCE NO. SP-947, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH THIRTY-SIX (36) LOTS: COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND SIX HUNDRED FIFTY THREE (1,653) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-60466 AND RT-89763 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAMES OF MARIA R. LAZARO AND HERMILINDA M. RODRIGUEZ (VENDORS), RESPECTIVELY, AND LOCATED AT LOT 810-A AND LOT 810-C, PSD-27214, BETSAIDA STREET, TAWID SAPA I, BARANGAY SAN AGUSTIN, NOVALICHES, QUEZON CITY, AS APPLIED FOR BY THE SAMAHANG MAGKAKAPIT BAHAY NG TAWID SAPA I, INC. (SAMAGTASA), (VENDEE). SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The subdivision plan of A SOCIALIZED RESIDENTIAL HOUSING PROJECT (BP Blg. 220) with thirty-six (36) lots : Community Mortgage Program containing an area of One Thousand Six Hundred Fifty-Three (1,653) square meters covered by Transfer Certificates of Title Numbered RT-60466 and RT-89763 of the Registry of Deeds of Quezon City, registered in the names of Maria L. Lazaro and Hermilinda M. Rodriguez (Vendors), respectively, and located at Lot 810-A and Lot 810-C, Psd-27214, Betsaida Street, Tawid Sapa, I, Barangay San Agustin, Novaliches, Quezon City, as applied for by the Samahang Magkakapitbahay ng Tawid Sapa, Inc. (SAMAGTASA), (Vendee), is hereby approved, subject to the conditions prescribed under Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Blg. 220, details of which are, as follows:
