ORDINANCE NO. SP- 965, S-2000

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A SOCIALIZED HOUSING PROJECT (BP BLG. 220) WITH ELEVEN (11) LOTS; COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF SIX HUNDRED TWENTY (620) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 13033 OF THE REGISTRY OF DEEDS OF QUEZON CITY, LOCATED AT LOT 40, FLS-2696-D; TATLONG HARI ST., SITIO AGUARDIENTE, BARANGAY STA. MONICA, NOVALICHES, QUEZON CITY, METRO MANILA, AND APPLIED FOR BY THE SAMAHANG MAGKAKAPITBAHAY NG SITIO AGUARDIENTE, INC. (SANTIAGO GROUP), SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP. 56, S-93 AND BATAS PAMBANSA BLG. 220.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
SESSION ASSEMBLED:

SECTION 1. The subdivision plan of a SOCIALIZED HOUSING PROJECT (BP Blg. 220) with eleven (11) lots, Community Mortgage Program, containing an area of six hundred twenty (620) square meters covered by Transfer Certificate of Title Numbered 13033 of the Registry of Deeds of Quezon City, located at Lot 40, Fls-2696-D; Tatlong Hari St., Sitio Aguardiente, Barangay Sta. Monica, Novaliches, Quezon City, Metro Manila, and applied for by the SAMAHANG MAGKAKAPITBAHAY NG SITIO AGUARDIENTE, INC., (Santiago Group), is hereby approved, subject to the conditions prescribed under Quezon City Ordinance no.
